1.0 UPPER AGE LIMIT / AGE RELAXATION

- 1.1 **Project Engineer:** Maximum Age limit for Un-Reserved/ EWS Categories is <u>28 Years</u> as on **Date of Walk-in-**Interview.
- 1.2 Maximum age limit is relaxed by 05 years for SC & ST, 03 years for OBC-NCL, 05 years for PwBD (UR), 08 years for PwBD (OBC-NCL) and 10 years for PwBD (SC/ST) candidates over and above the max. age limit prescribed at para 1.1 above.
- 1.3 Maximum age relaxation by 05 years is applicable for Ex-Servicemen & Commissioned Officers (including ECOs / SSCOs) subject to rendering minimum 05 years' service in Armed Forces and fulfillment of other conditions prescribed by Govt. of India.

4.0 RESERVATIONS, CONCESSIONS AND RELAXATIONS

- 4.1 Reservation of posts for SC, ST, OBC (NCL), EWS and PwBD (Persons with Benchmarked Disabilities with degree of disability 40% or above) are as per Government Directives.
- 4.2 Candidates seeking reservation / relaxations as SC / ST / OBC (Non-Creamy Layer) / EWS / PwBD will have to submit category certificate "ONLY in the Prescribed Proforma" meant for appointment to posts under the Government of India from the designated authority indicating clearly the candidate's caste, the Act / Order under which the category is recognized as SC/ST/ OBC (NCL) / EWS / PwBD. An application form without copy of valid certificates in prescribed format will be rejected.
- 4.3 If the SC / ST / OBC (NCL) / EWS / PwBD certificate has been issued in a language other than English / Hindi, the candidates will be required to submit a self-certified translated copy of the same in either English or Hindi.
- 4.4 Candidates must note that BDL follows only Central Government list and not State Governments list for SC/ST/OBC (NCL) / EWS. Similarly, candidates applying under Persons with Benchmark Disability (PwBD) category may note that Government of India rules will be applicable for any concession in this regard.
- 4.5 For getting the reservation benefits under OBC category, candidates need to furnish their OBC NON-CREAMY LAYER (NCL) certificate as per the format prescribed by Government of India. OBC category candidate who does not belong to "NON-CREAMY LAYER" are not entitled for OBC concessions and such candidates should indicate their category as "GENERAL" and will be considered under UR category.
- 4.6 For getting the reservation benefits under EWS category, candidates need to furnish their latest EWS certificate in the format as per DoPT Office Memorandum No. 36039/1/2019 Estt (Res) dated 31/01/2019 or subsequent amendment(s), if any.
- 4.7 Disability should not be less than 40% for the categories wherever PwBD reserved posts. A person, who wants to avail the benefit of relaxation, will have to submit a Disability Certificate issued by a Competent Authority as per the form V, VI and VII of Rule 18(1) under Chapter 7 of Rights of Persons with Disabilities Rules, 2017 dated 15.06.2017. The existing certificates of disability issued under the Persons with Disabilities Act 1995 (since repealed) shall continue to be valid for the period specified therein.

5.0 TENURE OF EMPLOYMENT

5.1 **Project Engineer** will be engaged on Fixed Term (Contract) Basis initially for a period of <u>ONE year</u>, which may be extended up to a maximum period of <u>FOUR years</u> (including initial period), based on the Organisational requirement and individual performance.

- 7.4 Candidates who fulfill all the requisite parameters and Qualification Requirements (QRs) will be shortlisted for Interview. Shortlisting of candidates for INTERVIEW will be based on the initial screening of applications.
